Reports

Chair:

- Field Directorate
 - o will be changing age groups back to U9, U11, U13, U15, U18
 - won't be implemented until the 2015-16 season
- Provincials
 - o U19 Tier 1 and Tier 2 and the Women's Invitational
 - February 8th 10th in Langley
 - Saturday through Monday
 - U12, U14, U16 Tier 1 and 2
 - February 21 23 in Burnaby
 - Friday through Sunday
 - coaches/managers meeting probably on the Thursday night
- coaches
 - o only 4 non-playing personnel allowed in the coaches walk
 - trainers must be properly certified
 - cannot coach
- schedule to be released sometime this week
- Tier 3
 - o after feedback from Tier 2 teams, everyone from U12 and U16 will declare, at this time
 - may change after the Fall Schedule
 - deadline to declare is December 13th
 - 2 teams from U14 Tier 2 (Mission and North Shore) indicated they will not declare
 - will stay on the regular schedule
 - o will revisit Tier 3 at the end of the Fall Schedule
- CLA rule that shorts must match uniforms
 - o IFL rule
 - all players

- goalies can wear track pants, but as long as they are the team colours
- o if the ref calls a player on this, they must sit out until they conform
- it was observed that this was not called at the Senior Men's Nationals
- Beth proposed a motion
 - All players should have matching coloured shorts and uniforms for all games and Provincials.
 Players will not be penalized if they do not conform to team colours
 - motion seconded by Trevor Webber
 - vote unanimous
 - carried
 - from Jody
 - clinicians have instructed all officials to conform to the new rules
 - o that being said, common sense should prevail
- Girls U10 and U8
 - Try-out Field Lacrosse 'camp'
 - hosted by the Adanacs
 - this Saturday 3:30 5:00 p.m.
 - at Cunnings
 - don't need to register
 - new players (eg. Box players) can sign a waiver
 - hot dogs for all participants and parents
 - gift cards for participants
 - need to know numbers by Thursday
 - will have goggles and sticks for brand new players
- Richmond Tournament
 - Remembrance Day week-end
 - 42 teams involved
 - o refs for tournament will not take precedence over league games
 - league games will not be cancelled due to a tournament
 - for teams involved, they can TBR

- Concern regarding Team BC
 - o took up 4 weeks of an 11 week schedule
 - conflicts with League play
 - o discussion about changing rules which will be brought to the FD Special Session in April

Treasurer:

• a few associations have fines for late or incomplete registrations

Registrar:

- The PCFLL has not improved with getting registrations in and completed correctly
 - o paperwork has to be in order
 - because of insurance issues
 - o issue with on-line registration waivers
 - o all information was given to the registrars prior to the deadline
 - eg who, where and when to send cheques
 - will need to discuss with Dirk and Beth timelines
 - currently the timelines are not working
 - October 15th was the PCFLL deadline
 - October 31 was the BCLA deadline
 - if there are any player/team changes, need to notify Karen ASAP

- suggests closing the database on the submission date
- recommend fines start on the day of notification
- registrars must send in the original registration forms
- things need to move in a more positive direction

Secretary: Nothing to report

Head Referee:

- so far, one case of a coach abusing a ref
- Issues brought up:
 - o videographer on the field and standing on a table
 - should this be allowed?
 - 'legally' cannot be in the coaches walk or players' box
 - all spectators should not be on the same side as the players
 - should not be on the field at all
 - any association could deny him permission to set-up
 - o U8 rule
 - when the ball hits the drop down and goes in, is that a goal or a dead ball?
 - contact
 - stick on stick
 - o clarification of flag-down and advancement of the ball
 - issue with the ball behind the goal
