- suggestion of having a 2 week schedule
  - give associations a chance to boost numbers

#### **Head Umpire:**

- suggestion that U12 go 8 vs 8
  - rules are changing
    - U12 will play ½ field with drop-down nets
    - play D with feet (no stick-checking)
    - 2 passes before scoring
      - 2<sup>nd</sup> pass must be in the attack area
    - U15 will have below the shoulder checking
      - no stick to body

- U19 will have full-checking
      - suggestion that the first couple of weeks play 7 vs 7
  - discussion
    - would help with numbers
    - agreement to U12 changes only
- September 15<sup>th</sup>
  - all games scheduled in Langley
    - U12s
      - 9:00 – 10:00 a.m.
        - 4 teams
    - U15s
      - 10:00 a.m. – 1:00 p.m.
        - 6 teams
    - U19s
      - 1:00 – 2:00 p.m.
        - 2 teams
  - by September 5<sup>th</sup>, Beth will send the U15 schedule for the first week
    - we will see what happens after that
- no piercings allowed
  - wedding rings, religious or ceremonial jewelry can be taped or removed
- allowed two time-outs per game and one during overtime
  - coach or whoever has possession of the ball can call the time-out
- discussion regarding Rule 10 (hand-out given out)
  - “When a goal is scored – shooter must drop stick. If they don’t, goal does not count”
    - a coach or captain can call for a stick check
      - if it is illegal, the goal does not count
        - goalie ball
        - if it is legal, the goal counts
          - attack ball at centre
  - could take a lot of time
    - with limited field time, this could be an issue
  - decision to eliminate, except at Provincials
