#### **Chair:**

- Field Directorate
  - changing age divisions at the national level
    - U7, U9, U11, U13, U15, U18
    - Team BC, for this year, will stay the same
      - Camps will have new divisions
    - Do we want to change for 2015/16 season?
  - changing U16 and U19 nationals to the Thanksgiving week-end
    - in conjunction with the Senior Men's
    - may affect players who are away at school
      - more so U19 players
- Coaches and Officials Special Session
  - September 13<sup>th</sup> at the Executive Inn on Lougheed Hwy. (Burnaby)
    - 72% of coaches were NOT certified
      - most have not completed their workbook
      - in 2013, 600 coaches did not complete the workbook, in Box
    - on the bench, 4 certified coaches and a trainer
      - trainer must be a first responder or have St. John's Ambulance
